TRA Long Range Planning Committee Project Proposal

(updated December, 2023)

Instructions

The purpose of the TRA Long Range Planning Committee (LRPC) is to advise the TRA Board of Trustees on the merit of various projects proposed to enhance the TRA Property that is used for the annual Old Timers Reunion (OTR) and by groups that rent the TRA Property outside of the time the property is utilized for OTR. During the deliberations of the LRPC, we keep in mind the TRA Site Vision Statement (2019PC1) that was written by the LRCP and approved at the 2019 Spring TRA Board of Trustees Meeting: "The TRA Site Vision Statement: To provide a sustainable venue capable of supporting the annual OTR event with a regular attendance of 2000 persons". The LRPC reviews each project and makes recommendations based on a project's contribution to the OTR experience, enhancement to the utilization of the TRA property by third parties, and the level of planning and forethought that has gone into the project. If a project is supported by the LRPC, it is presented to the TRA Budget Committee for funding consideration and then it is forwarded to the TRA Board of Trustees for deliberation, approval, or denial.

This form serves as your project proposal to the LRPC. The LRPC evaluates proposals based on the following criteria:

- 1. Level of planning that has gone into the project.
- 2. Fiscal value of the project (In other words, does the project value justify the cost to complete it).
- 3. Value to the TRA Site and the OTR event.
- 4. Consideration of durability of a finished project for at least 10 years.
- 5. Resources needed to complete and maintain proposed project (funds, volunteer hours, real estate required for project on the TRA Property, etc).
- 6. The extent that the project meets the TRA Site Vision Statement.

Please complete all sections of this form. The project proposal you outline in this form will be your main communication to the LRPC. The items we ask you to detail in this form have been carefully chosen, and we feel that each item of information requested in this form requires forethought and planning before a project can be executed. Any project proposals that do not address the required items will be assumed to be inadequately planned, and will not be recommended for funding.

Should the LRPC feel that your project proposal is detailed enough to be considered at the next LRPC Meeting, you will be assigned a liaison to work with you to address any outstanding questions / concerns that will need to be addressed before the LRPC meets to discuss your proposal.
